## **MINUTES**

## March 8, 2022

The Winchester City Council met in regular session Tuesday, March 8, 2022 at 5:00 p.m.

Mayor Harrell called the meeting to order with a prayer by Councilman Steve Cagley and the Pledge of Allegiance was led by Councilwoman Lucas.

The Mayor began the meeting with a Public Hearing for Ordinance #1044, an ordinance amending Zoning Ordinance #506 of Winchester, Tennessee to rezone property on First Avenue NW and North Shephard Street to R3A, High Density Residential District from the current zoning classification of R2, Medium Density District and C2, Commercial Highway Service District. No one spoke for or against this ordinance.

Mayor Harrell closed the Public Hearing and the meeting continued with unfinished business. Councilwoman Johnson made a motion to approve the February 8, 2022 City Council Minutes. Councilman Sisk seconded the motion and all members voted in favor of said motion.
